

**Bay View Mini-Putt and Zipline**  
**Customer Party/Event Agreement**

All policies must be read by party coordinator, initialed, and returned to Bay View Mini-Putt and Zipline at the time of scheduling a party/event date.

**Mini-Putt:**

- Children under 12 years of age cannot be left unattended at any time on the mini-putt course. We recommend at least one parent or guardian supervise up to six children.
- Appropriate footwear and clothing are required.
- No pets allowed on course.
- No running on premises.
- Do not hit putters on anything except for golf balls.
- Do not retrieve golf balls from out-of-bounds areas. Please ask for assistance from staff.

**Zipline:**

- All zipline riders must sign a waiver for the zipline.
- If a participant is under 18 years of age, a parent or legal guardian must fill out the waiver on his/her behalf. Therefore, with the parent's/legal guardian's signature and information, the parent/legal guardian does not need to be present for the child's ride.
- Waivers are available on-line or in-person from our staff. For large groups, Bay View Mini-Putt and Zipline recommends waivers be completed prior to arrival.
- Riders must be at least 6 years old and weigh between 60 to 250 pounds.
- Riders must not be pregnant, have a heart condition, or back injuries.
- Closed-toe, athletic type shoes must be worn.
- If a rider wishes to do an additional ride (add-on ride), he or she must inform the staff and the ride must be done immediately without removing gear.

**General:**

- A service/cartage fee of \$50-\$75 will be added to parties who plan on bringing their own food.
- No smoking or alcoholic beverages allowed in the party areas.
- Party coordinator is responsible for any damage or loss of property and/or equipment incurred to Bay View Mini-Putt and Zipline by any attending/invited guests or organizations contracted.
- Bay View Mini-Putt and Zipline is not responsible for damaged, lost, or stolen articles and personal belongings prior to, during or following the party.
- Party areas may be decorated 30 minutes prior to designated event time (1 hour for course rentals). Please no staples, nails or confetti.
- Disposable helium tanks may not be left on the premises.
- All outside equipment and/or entertainment must be pre-approved by Bay View Mini-Putt and Zipline.

**Catering:**

- Orders are recommended to be made at least 48 hours in advance. For larger orders (50 or more), one week is preferable.
- An additional \$50 deposit must be made for all catering orders. Deposit will be deducted from final bill at event conclusion.
- Cancellations made less than 24 hours in advance will result in forfeiture of deposit.
- Customer is responsible for entire order for cancellations made less than 12 hours prior to event.

**Payment:**

- A \$50 deposit to hold the date and time of the event will be required at the time of reservation (\$100 for course rental). Deposit will be deducted from final bill at event conclusion.
- Party coordinator is responsible for settling the bill at event conclusion.
- Party coordinator can elect to pay for activities for their guests, or guests can pay for themselves. Either way, the discounted party rates for activities will be given, but only during the selected time frame of the party.
- Cash, credit card, and checks are all acceptable forms of payment. Receipts will be offered at the time of payment.
